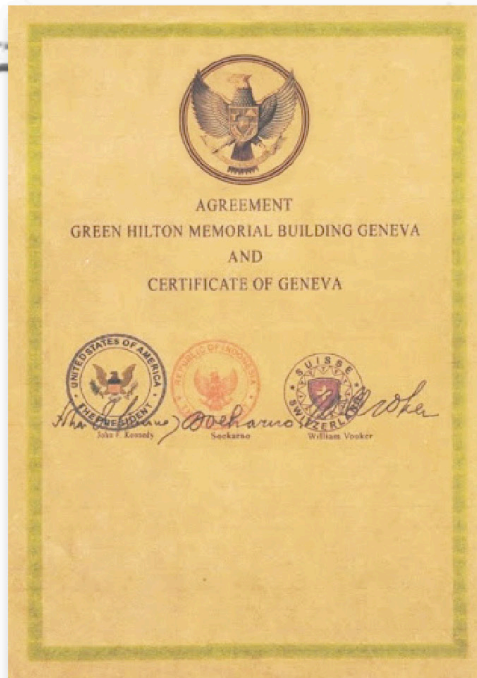

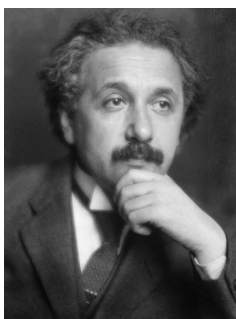


STEWARDED SOVEREIGNTY

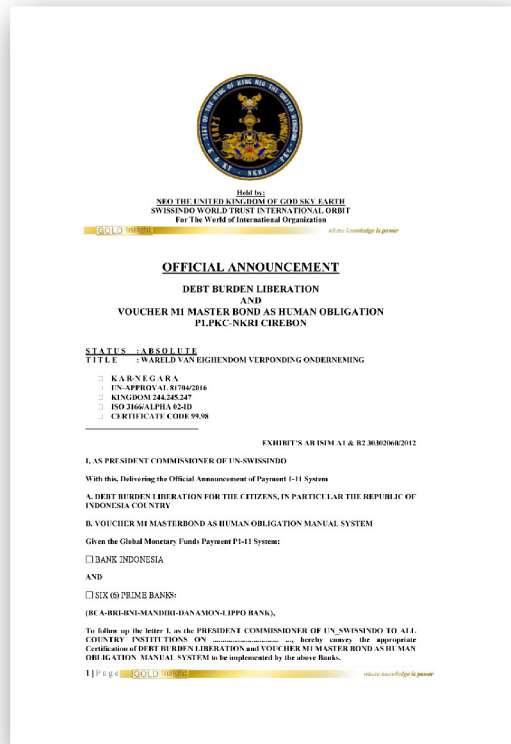

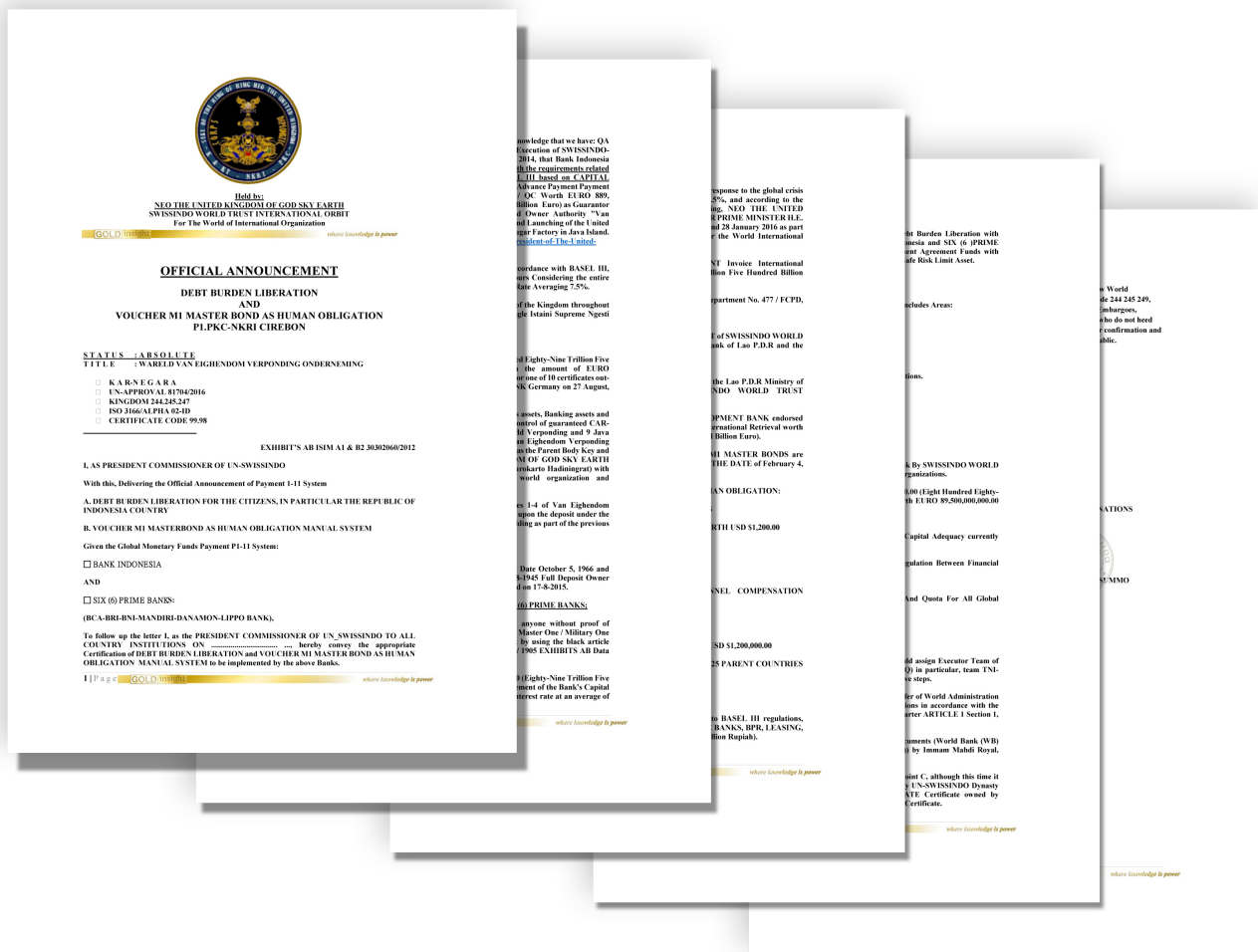

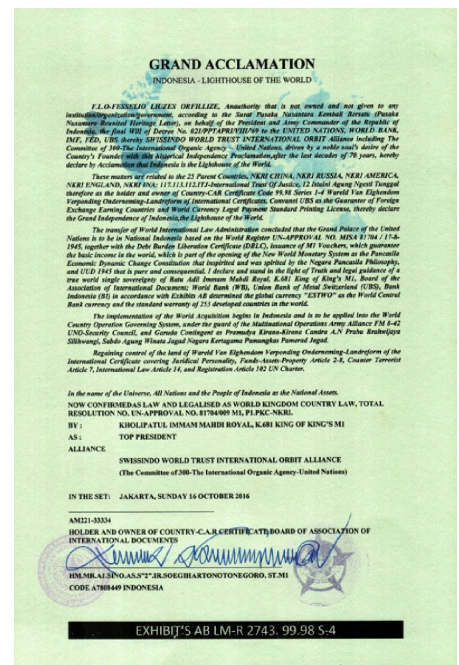
